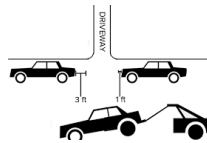

REPORTS OF OFFICERS:

- Ø Susan Butler – Secretary, asked for a motion to accept the minutes for last meeting as published in the February 2018 PAR II newsletter. Motion was made and 2nd. All approved
- Ø New Residents present? Sharon asked if we had any new homeowners present. We welcomed Jan and Doug Armstrong.
- Ø Treasurer Manuel Hevia reported that we have only 39 homes that are delinquent in dues, he started making phone calls and has reduced that number as well as having made payment plan arrangements for 4 other homeowners. We currently have as of February 28 2018 approximately \$80,000 in the operating account.

REPORTS OF THE COMMITTEES:

- Ø Screening: Gilda Pagano- Nothing to report, no new homeowners moving in this month.
- Ø Entertainment: Theresa – nothing to report or planned except the ladies luncheon which will be at the Olive Garden on April 19th.
- Ø Social Club: Bob Mclellan – Was not present but wanted us to announce that the next Lightening bingo game will be on April 5 at 7:15pm. It is only \$2.00 to join in plus the nickels you use. Please bring nickels, and there will be some there available for sale.

OLD BUSINESS:

- Ø President – Sharon Hevia, announced that our accountant – would like as many emails as possible, He would like to email your statements if possible, rather than mailing. This will save us money each quarter. Would also like to encourage all to set up an auto debit plan, so you will know that you are always on-time. If you do not have email or do not want to use email, your statements will still be mailed.
- Ø Purchase of Clubhouse. Closing will be on March 22
- Ø Remodeling – because of the change in ownership, the building needs to be updated and brought up to ADA compliance. We will try to have some drawings at the next meeting to show, the biggest changes will be the kitchen and the bathrooms. There was discussion about bringing back the shuffleboards and starting a league. There were suggestions to have more windows along the pool where the exercise room will be. And in the game room.

NEW BUSINESS:

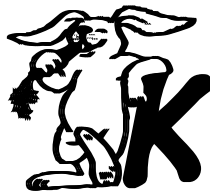
- Ø Parking complaints – the board has had numerous complaints about the parking on some streets, there are just too many cars, driveways and right of ways are being blocked or they are making it difficult to maneuver out your driveway or turns. Asked if anyone was experiencing problems, no one was present, so further discussion will be tabled until homeowners come in for meetings to express any concerns. We do not want to enforce the stringent rules on all 302 homes because of the actions of some. Unless homeowners come in and express their concerns, we will have to just work with the challenges we have.
- Ø Yards – it is that time of year when we should all take a look at our yards and maintain and clean up. You cannot store your awnings on the side of the house, and shutters must be taken down. Clam shell shutters need to be raised. Should be storing items loosely on carports or on the side of the house. You are allowed to have a shed inside your carport as long as it is attached to the wall or floor for safety.
- Ø Discussion was had on bulk pick-up, some people are putting it out days early, but it is difficult to get it done early on bulk day, 2 or 3 days is acceptable. There are people who do not live in PGII coming in on bulk pick-up day to drop off their bulk at the corners. If anyone sees this, please get a photo. It is against the law for anyone to be dumping.
- Ø Raffle tickets – to encourage our homeowners to attend meetings, we will be having a free raffle each meeting. This month's winner was Jacques Baptiste. He is the proud new holder of a 25.00 visa gift card.

With no more new business or questions from the floor, a motion was made and seconded to adjourn at 8:13pm

IMPORTANT REMINDERS

You have made a personal decision to live in a community that is a registered association. Associations are governed by a set of rules. The rules are for all residents ---- NO EXCEPTIONS.

PARKING

There are no defined parking spaces on community streets. Spaces cannot be saved. Our streets are maintained by the City of Margate and you can park anywhere as long as you:

- Park on the correct side of the street, which is THE SIDE OPPOSITE of the NO PARKING signs and in the direction of the traffic flow.
- DO NOT BLOCK ANYONE'S DRIVEWAY.

POOL RULES

- The pool is open from dawn to dusk. NO SWIMMING AFTER DARK.
- Please be considerate as to the number of guests you entertain in the pool.
- All homeowners and their guests must have tags when using the pool. Tags may be purchased at every homeowner's meeting. Anyone not having tags will be asked to leave the pool.
- **HOMEOWNERS MUST ACCOMPANY GUESTS IN THE POOL AREA,** Particularly residents with children.
- Food or beverages, including alcohol are **NOT** allowed in the pool area.

ATTENTION DOG OWNERS!

- All dogs must be leashed and restrained at all times.
- Do not walk your dog on anyone else's property.
- You must clean up after your dog!

DO NOT FEED THE MUSCOVY DUCKS!

Feeding the ducks will solidify your friendship with the blunt-billed birds for life. So will leaving household trash outside in plastic bags. Place trash in garbage cans. It is against the law to feed the ducks in Margate and can result in fines. Muscovies get their nutrients from a natural diet of bugs and pond algae.

PERSONAL YARD AND GARAGE SALES

Our by-laws prohibit all yard and/or garage sales.

BE MINDFUL OF YOUR NEIGHBORS

We live in a neighborhood with the homes in close proximity to each other. It is extremely important - **and the homeowner's responsibility** - to keep trees and shrubs trimmed. Not only does it make our community look more attractive, it can eliminate hard feelings between neighbors if your tree should damage your neighbor's property. Keeping your bushes trimmed eliminates places for iguanas to hide. **Iguanas carry salmonella and botulism.** If you are unable to maintain your trees and shrubs yourself, several of the mowers will be happy to do it for you for a reasonable fee.
