#### REPORTS OF OFFICERS

Secretary, Susan Butler, asked for a motion to accept the minutes of the last meeting as published in the April 2018 PARII newsletter. Motion was made and 2<sup>nd</sup>. All approved

President, Sharon Hevia, asked if we had any new homeowners present. There were no new residents present.

Treasurer, Manuel Hevia, reported that we have 4 homes that are delinquent and sent to collections. Two of the owners have passed away and are in probate, one having an unknown status. There are a number of homes that have small balances and are probably late fees, where payment had crossed in the mail and we should write those off.

**Entertainment** - Theresa McLellan - Nothing is planned. It is difficult to get residents to participate. We have enough volunteers, but no one wants to participate. Still debating on a Holiday Party this year.

**Social Club** - Bob McLellan - We still have lightning bingo 2 nights a month. PartII bowling will be joining another league because we do not have enough bowlers for our own league. Only 6 bowlers. Bob has seen only a couple of our own board members participate and would like to see more. By a show of hands, members want to have a Holiday Party and will attend. There was also discussion about possibly planning a function during the day on weekends when people are available. Some residents do not like to drive at night

#### OLD BUSINESS:

Parking complaints once again were discussed without a resolution. When the option of towing cars parked on the street overnight was brought up, no one at the meeting wanted that. Cars parked overnight (which our covenants prohibit), parking too many cars in the street and not in your driveway as well as parking on the curve of the streets creates a very dangerous situation. Apparently, neighbors cannot be considerate of others when parking. Some homes have as many as 4 cars, which make it impossible to park in their own driveway. If it is an issue, we will do our best to assist the violators with not getting a ticket or being towed. A show of hands favored towing showing that some are willing to enforce the covenants. Discussion was tabled until next meeting.

#### NEW BUSINESS

It was brought up at the meeting that there is a car without plates parked in a driveway of a home whose windows are blocked out from inside and no evidence of someone living there.

There is also a house off of Margate Blvd that has had a blue tarp on the roof since Irma. It was suggested that the owners are possibly having a dispute with their insurance company.

It was noted that there has been a white van with teens driving around the neighborhood and we should be attentive to our community and be aware.

It appears as if no one is reading the Par II newsletter because 95% of all calls to the board are questions that can be answered by reading the newsletter. A motion was made to publish the ParII on our web site and not distribute by paper and printing 50 copies and placing them in the clubhouse. It costs \$150 per month to print the paper. Discussion ranged from getting more sponsors, to what affect it would have on the current sponsors. If we would publish on the web only, would we need sponsors? A vote was taken and passed to continue printing. New Ideas of what to put in the newsletter was requested.

To encourage homeowners to attend the meetings, we will have a free raffle each meeting for a \$25 VISA gift card. May's winner was Thomas Johnson of 6040 NW 69<sup>th</sup> Avenue.

**You have made a personal decision to live in a community that is a registered association. Associations are governed by a set of rules. The rules are for all residents ---- NO EXCEPTIONS.**

## **PARKING**

There are no defined parking spaces on community streets. Spaces cannot be saved. Our streets are maintained by the City of Margate and you can park anywhere as long as you:

- Park on the correct side of the street, which is THE SIDE OPPOSITE of the NO PARKING signs and in the direction of the traffic flow.
- DO NOT BLOCK ANYONE'S DRIVEWAY.

## **POOL RULES**

- The pool is open from dawn to dusk. NO SWIMMING AFTER DARK.
- Please be considerate as to the number of guests you entertain in the pool.
- All homeowners and their guests must have tags when using the pool. Tags may be purchased at every homeowner's meeting. Anyone not having tags will be asked to leave the pool.
- **HOMEOWNERS MUST ACCOMPANY GUESTS IN THE POOL AREA,** Particularly residents with children.
- Food or beverages, including alcohol are **NOT** allowed in the pool area.

## **ATTENTION DOG OWNERS!**

- All dogs must be leashed and restrained at all times.
- Do not walk your dog on anyone else's property.
- You must clean up after your dog!

## **DO NOT FEED THE MUSCOVY DUCKS!**

Feeding the ducks will solidify your friendship with the blunt-billed birds for life. So will leaving household trash outside in plastic bags. Place trash in garbage cans. It is against the law to feed the ducks in Margate and can result in fines. Muscovies get their nutrients from a natural diet of bugs and pond algae.

## **PERSONAL YARD AND GARAGE SALES**

Our by-laws prohibit all yard and/or garage sales.

## **BE MINDFUL OF YOUR NEIGHBORS**

We live in a neighborhood with the homes in close proximity to each other. It is extremely important - **and the homeowner's responsibility** - to keep trees and shrubs trimmed. Not only does it make our community look more attractive, it can eliminate hard feelings between neighbors if your tree should damage your neighbor's property. Keeping your bushes trimmed eliminates places for iguanas to hide. **Iguanas carry salmonella and botulism.** If you are unable to maintain your trees and shrubs yourself, several of the mowers will be happy to do it for you for a reasonable fee.




